Mr. Geyer made a motion to accept the report of the Treasurer, transfer to payroll and pay the bills as listed. Mr. Stoner seconded the motion; motion carried, 3-0.

### AGENDA:

Mr. Josh Kalp, The EADS Group, reported on grants and projects. He presented a pay application for CBF Contracting contingent to the receipt of close out paperwork.
